AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (KETETAPAN KASTAM) (PINDAAN) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 142 Akta Kastam 1967 [Akta 235], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Ketetapan Kastam) (Pindaan) 2023**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Januari 2023.

Pindaan peraturan 2

2. Peraturan-Peraturan Kastam (Ketetapan Kastam) 2007 [P. U. (A) 149/2007], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan 2(1) dengan menggantikan perkataan “Jadual A” dengan perkataan “bentuk dan cara yang ditentukan oleh Ketua Pengarah”.

Pindaan peraturan 3

3. Peraturan 3 Peraturan-Peraturan ibu dipinda—

(a) dalam perenggan (1)(a), dengan menggantikan perkataan “Jadual A” dengan perkataan “permohonan”; dan

(b) dalam subperaturan (3), dengan menggantikan perkataan “Jadual B” dengan perkataan “bentuk dan cara yang ditentukan oleh Ketua Pengarah”.

Pindaan peraturan 7

4. Subperaturan 7(1) Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan “Jadual C” dengan perkataan “bentuk dan cara yang ditentukan oleh Ketua Pengarah”.

Pemotongan Jadual A

5. Peraturan-Peraturan ibu dipinda dengan memotong Jadual A.

Pemotongan Jadual B

6. Peraturan-Peraturan ibu dipinda dengan memotong Jadual B.

Pemotongan Jadual C

7. Peraturan-Peraturan ibu dipinda dengan memotong Jadual C.

CUSTOMS ACT 1967

CUSTOMS (CUSTOMS RULING) (AMENDMENT) REGULATIONS 2023

IN exercise of the powers conferred by section 142 of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Customs Ruling) (Amendment) Regulations 2023**.

(2) These Regulations are deemed to have come into operation on 1 January 2023.

Amendment of regulation 2

2. The Customs (Customs Ruling) Regulations 2007 [*P. U. (A) 149/2007*], which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 2(1) by substituting for the words “Schedule A” the words “the form and manner as determined by the Director General”.

Amendment of regulation 3

3. Regulation 3 of the principal Regulations is amended—

(a) in paragraph (1)(a), by substituting for the words “Schedule A” the words “application”; and

(b) in subregulation (3), by substituting for the words “Schedule B” the words “the form and manner as determined by the Director General”.

Amendment of regulation 7

4. Subregulation 7(1) of the principal Regulations is amended by substituting for the words “Schedule C” the words “the form and manner as determined by the Director General”.

Deletion of Schedule A

5. The principal Regulations are amended by deleting Schedule A.

Deletion of Schedule B

6. The principal Regulations are amended by deleting Schedule B.

Deletion of Schedule C

7. The principal Regulations are amended by deleting Schedule C.
