**Pindaan kaedah 2**

2. Kaedah-Kaedah Fee Peperiksaan Kelayakan Bahasa Malaysia (Orang-Orang Berkelayakan) 1984 [*P.U. (A) 375/84*], yang disebut “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda dalam kaedah 2 dengan menggantikan perkataan “satu ratus lima puluh ringgit” dengan perkataan “tiga ratus lima puluh ringgit”.

**Pindaan kaedah 3**

3. Kaedah 3 Kaedah-Kaedah ibu dipinda dengan menggantikan perkataan “satu ratus ringgit” dengan perkataan “satu ratus lima puluh ringgit”.

LEGAL PROFESSION ACT 1976

BAHASA MALAYSIA QUALIFYING EXAMINATION (QUALIFIED PERSONS)  
FEES (AMENDMENT) RULES 2021

IN exercise of the powers conferred by subsection 6(2) of the Legal Profession Act 1976 [Act 166], the Legal Profession Qualifying Board makes the following rules:

**Citation**

1. These rules may be cited as the **Bahasa Malaysia Qualifying Examination (Qualified Persons) Fees (Amendment) Rules 2021**.

**Amendment of rule 2**

2. The Bahasa Malaysia Qualifying Examination (Qualified Persons) Fees Rules 1984 [*P.U. (A) 375/84*], which in these Rules are referred to as the “principal Rules”, are amended in rule 2 by substituting for the words “one hundred and fifty ringgit” the words “three hundred and fifty ringgit”.

**Amendment of rule 3**

3. Rule 3 of the principal Rules is amended by substituting for the words “one hundred ringgit” the words “one hundred and fifty ringgit”.
