

SALES TAX ON LOW VALUE GOODS (LVG)

- For information, the legislations related to Sales Tax on Low Value Goods (LVG) have come into force on 1 JANUARY 2023.
- While the effective date for charging and levying Sales Tax on LVG will be from 1 APRIL 2023.
- 3. In accordance with the legislations related to Sales Tax on LVG,
 - i. any person whether in Malaysia or a foreigner;
 - ii. who sell Low Value Goods (LVG);
 - iii. brought into Malaysia by land, sea or air mode and
 - iv. the total sales value of LVG into Malaysia exceeds RM500,000 within12 months

is responsible for being registered as a Registered Seller (RS).

- 4. Applicants can start applying to be registered from 1 JANUARY 2023.
