Selected Recent Experience in Tax Litigation

- (a) Successfully represented Sandakan Edible Oils Sdn Bhd, a Malaysian subsidiary of a Fortune Global 500 company Wilmar International Limited in a landmark transfer pricing appeal before the High Court and the SCIT. This is the first decision to address Section 140A of the Income Tax Act 1967 ("ITA") and the Income Tax (Transfer Pricing) Rules 2012.
- (b) Successfully represented **Deloitte**, the professional liquidators of a company in liquidation in judicial review proceedings at the High Court. In August 2022, the Director General of Inland Revenue ("**DGIR**") agreed to discharge the entire tax assessment of more than RM 100 million issued against the company. The issue concerns the tax treatment of gains from the disposal of lands by the company during liquidation.
- (c) Successfully represented Cash Band Berhad, in a landmark dispute before the High Court on whether proceeds received from a joint venture development in the form of percentage of GDV is chargeable to income tax. We successfully argued before both the High Court and SCIT that such proceeds are capital gains and not chargeable to income tax.
- (d) Successfully represented a **subsidiary of the Naza Group** in property development in a RM 200 million dispute before the SCIT. The SCIT held that

gains from the taxpayer's disposal of 11 parcels of land are capital gains taxable under the Real Property Gains Tax Act 1976 and not taxable under the ITA.

- (e) Successfully represented Tower Real Estate Investment Trust, a listed REIT before the High Court in respect of a RPGT assessment raised by the Inland Revenue Board ("IRB"). This is the first decision to address the legal status of a REIT and its taxability under the Real Property Gains Tax Act 1976.
- (f) Acted for an entity of the Standard Chartered Group in judicial review proceedings against the Malaysian Digital Economy Corporation ("MDEC"). The dispute concerns the extent and scope of certain MSC incentives granted by MDEC and the Ministry of Finance ("MOF"). Upon extensive settlement negotiations, MDEC together with the MOF agreed to grant the tax incentives to the company based on MSC status.
- (g) Successfully represented the Swiss and Malaysian entities of a global software company in 2 separate judicial review proceedings at the High Court. The dispute concerns the definition of royalty in the Malaysian Income Tax Act 1967 ("ITA") and the Swiss-Malaysian DTA. In September 2022, the High Court granted leave for the companies to commence judicial review and a stay against the disputed decisions made by the DGIR and the IRB.
- (h) Successfully represented an entity of the DRB-HICOM Group in judicial review proceedings to challenge bills of demand issued by the Director General of Customers ("DGOC") for excise duties. The case involves a dispute relating to method of computing the Open Market Excise Value of automobiles manufactured by the Company. We successfully obtained leave to commence judicial review and a stay against payment of the disputed duties.
- (i) Representing a Bursa-listed entity of the IOI Group in judicial review proceedings to challenge tax assessments of RM 16 + million by the DGIR. The dispute relates to the DGIR's decision to disallow tax deduction of interest expenses incurred by the company. We successfully secured an interim stay against payment of the disputed taxes.
